RECIPE

French Onion Dip

1/4 cup dried Toasted Mincd Onions
3/4 teaspoon kosher salt
1 teaspoon dried parsley
1 teaspoon dried mustard
1/4 teaspoon ground black pepper
1-1/2 cups sour cream
3/4 cup mayonnaise

Combine onions, salt, parsley, mustard and pepper in a small, airtight container.

Mix sour cream and mayonnaise in a medium bowl. Add about 5 tablespoons of the onion mixture. Stir thoroughly to blend and add additional onion mix as needed. Cover and refrigerate for at least 1 hour. Serve with potato chips or crudités.

Makes 2-1/4 cups

Crowd-pleasing onion dip is easy to make from scratch. Feel free to make the onion soup mix ahead of time, as it can be stored at room temperature in your pantry for up to six months. Then, use it to flavor a creamy mix of sour cream and mayo that'll get plunked with chips or fresh-cut veggies.
